黃蜂集團私隱政策

黃蜂集團會如何處理收集到的資料：

黃蜂集團要求租用人所提供的個人資料，只用作聯絡租用人及核實身份之用，黃蜂集團並會妥善保存及保密處理已收集之個人資料。如租用人拒絕提供有關資料，黃蜂集團有權拒絕向租用人提供租賃服務。

安全：

為確保閣下的資料安全，並為避免未獲授權的存取或披露，黃蜂集團已採取適當程序，以保障及保護黃蜂集團在網上收集到的資料。

連接其他網站的連結：
